

How to Update Emergency Accommodations Availability

Upon receiving an email from Visit St. Pete/Clearwater indicating that the CVBs **Emergency Availability Information Grid** has been activated because of an imminent weather-related threat, please reference the steps below to provide current room availability for your property.

NOTE: If you do not update your room availability online, you will be contacted by phone by PhaseV, the CVBs official fulfillment and call center partner, to do so. With prior approval from the accommodation, PhaseV may update your room availability on your behalf.

Step 1: Login to the Data Engine using the exact username and password provided in the email.

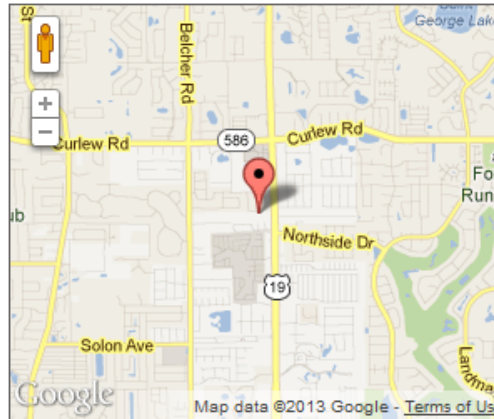
